Dear Sir

Your kind favour of the 23rd came only to hand, thanks for the kindness.

As regards the change in the settlement, it has greatly improved as I stated in my last.

I have opened a store and the settlers all bring their letters here to be posted also to receive their letters and papers, As I told in my last letter I let them use my box at Minden and they come to my place the same as though I kept an Office, but it is not so convenient as I cannot go down only when I have business there has 13 letters and 10 newspapers passed through my hands since yesterday morning for the settlers and there is hardly a day but what there is some person here inquiring for letters or paper or with letters to post even to money letters which I do not like passing through my hands in that shape as I often send them down by the first chance and I have to keep a quanty of stamps on hand accommodate what I have stated is nothing unusual for it often exceeds it. Hoping we will be granted an Office, I remain Yours

To the Honourable the Postmaster General

Honourable Sir

Some two years ago last March, I petitioned you through the member for the East riding of Peterborough desiring a Post Office in the Maple Lake settlement, I also solicited the favour this spring on behalf of the settlement through the same source, as the settlement has improved very much lately and you kindly informed me you would direct the Inspector to make inquiries and he done so (now I do not wish to find fault or blame the Inspector, he came up to Minden so I am informed) and consulted a few persons there and then left for Mr S.S. Peck formerly P.M. of Minden to name the place for it and he has named a place within 1½ miles or 2 miles at the fartherest from Carnarvon P.O. and where there are very few settlers that it will accomidate and a good ways of the road also no place of public resort which would leave a great number of the settlers 8 and 9 miles to travel to receive or post a letter or paper and be no advantage to any but a very few, now the settlers has requested me to write you and see if you would not grant us one in this settlement. If you think it necessary or if you would like to have us do so we will send in a petition.

Now it can come by the way of Haliburton which is only 10 miles from this place and would only cost about \$80. per year and by granting us the favour you would be enhancing the settlement of this and ajoining township (and we do not think it right to take the childrens bread and cast it to the dogs (politically)). I have been told two reasons why he name the place he did which I do not like to mention.
